## Maha Privilege Health Card

## **Terms and Conditions**

- 1. Maha Privilege Health Card is offered in three categories.
- I. General Citizens II. Senior Citizens III. Defence Personnel.
- 2. Maha Privilege Health Card is offered for a very nominal contribution:

For General Citizens: Rs. 300 per person, For Senior Citizens Rs.200 per person and For Defence Personnel Rs.200 per person.

- 3. Special discounted rates of Rs 150 per person are offered in general category for a family of 5 to 10 members consisting of (Husband, wife, mother and father of husband, sons, and daughters)
- 4. One free consultancy per member shall be given with Vaidya in every quarter (3 months).
- 5. Validity of cards shall be for one year from the date of issue. After two years, cards shall be renewed with a contribution of Rs. 100 for the period of the next 1 years.
- 6.
